Not illustrated. 1913 Excerpt: ...or refuses to pay the same after demand, the amount shall be a lien in favor of the United States, from the time when the assessment list was received by the collector, except when otherwise provided, until paid, with the interest, penalties, and costs that may accrue in addition thereto, upon all property and rights belonging to such person', and in the eighth paragraph of said section 38, Act of August 5th, 1909, it is provided, that 'all laws relating to the collection, remission and refund of internal revenue taxes, so far as applicable to and not inconsistent with the provisions of this section, are hereby extended and made applicable to the tax imposed by this section'. The method of assessing the tax and collecting the same, as provided for in the act itself, and in the general statutes, appears to be as follows: On or before March 1 of each year returns are required to be made by the corporation, joint stock companies and associations liable for the tax to the Collector of Internal Revenue of the district in which they have their principal places of business. These returns are forwarded by the collector to the Commissioner of Internal Revenue, who shall make the assessments thereon. By section 3183, Revised Statutes, the duty of collecting all taxes in their respective districts is imposed by law on the collectors or their deputies, and by section 3184 it is provided that the collector shall in person or by deputy, within ten days after receiving any list of taxes from the Commissioner of Internal Revenue, give notice to each person liable to pay any taxes stated therein, specifying the manner in which such notice shall be given. And in the fifth paragraph of section 38 of the Act of 1909, it is provided that assessments shall be made, and the sever...
